PLEDGE PROGRAMS

Pledges for the Platinum, Gold, and Silver Circles are welcome in annual increments. If you wish to donate through the pledge program, payments must be made in a minimum of 20% increments over a maximum of five years. Recognition and benefits will be given each year at the level of the annual donation with recognition at the pledge level in the final year.

Silver Circle

Pledge of \$2,500 over five years (at \$500 per year):

Years One – Four: Recognition at the Patron level, receiving Patron benefits.

Year Five: Recognition at the Silver level, receiving Silver Circle benefits.

Pledge of \$2,500 over two years (at \$1,250 per year):

Year One: Recognition at the Bronze level, receiving Bronze Circle benefits.

Year Two: Recognition at the Silver level, receiving Silver Circle benefits.

Gold Circle

Pledge of \$6,250 over five years (at \$1,250 per year):

Years One – Four: Recognition at the Bronze level, receiving Bronze Circle benefits.

Year Five: Recognition at the Gold level, receiving Gold Circle benefits.

Pledge of \$6,250 over two years (at \$3,125 per year):

Platinum Circle
